RESOLUTION

**A RESOLUTION AUTHORIZING THE AWARD OF AN EMERGENCY
REPAIR CONTRACT TO ANZELONE ELECTRICAL COMPANY, LLC**

WHEREAS, the City of Wildwood (the “City”) experienced a failure and/or interruption in electrical service affecting City Hall and certain municipal operations, thereby creating a condition that jeopardizes the ability of the City to safely provide essential municipal services; and

WHEREAS, on March 6, 2026, the City Engineer provided correspondence to the City regarding the damage and opined that the same resulted in potential harm to the safety and health of the personnel and public utilizing City Hall and needed to be addressed on an emergent basis; and

WHEREAS, the City determined that an electrician was needed on an emergent basis to address the power failure and restore power to City Hall and affected municipal buildings; and

WHEREAS, the Local Public Contracts Law permits the award of an emergency contract pursuant to N.J.S.A. 40A:11-6, without public advertising for bids, when an emergency affecting the public health, safety or welfare requires the immediate delivery of goods or the performance of services; and

WHEREAS, the emergent condition and need for the emergency electrical repairs was communicated to the City’s Purchasing Agent, Chief Financial Officer, and Business Administrator, who confirmed the emergent nature of the condition and the necessity of awarding the contract immediately; and

WHEREAS, Anzelone Electrical Company, LLC, possesses the technical skills and capabilities necessary to address the outage and restore electrical service to the affected municipal facilities; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the City of Wildwood, County of Cape May, State of New Jersey as follows:

1. That the provisions of the above preamble of this Resolution are hereby incorporated herein, by this reference, as if set forth at length.
2. That the City hereby ratifies and approves the award of an emergency contract to Anzelone Electrical Company, LLC, 1102 Route 9 South, Cape May Court House, NJ 08210 in the amount of Eighty Thousand Seven Hundred Fifty-Five (\$80,755.00) Dollars, as more specifically set forth in the subject invoices, attached hereto and incorporated by reference herein.
3. That the Mayor, City Clerk, Chief Financial Officer, and all other appropriate City officials are hereby authorized and directed to take any and all actions necessary to effectuate the purpose of this Resolution, including the processing of payment for the emergency work performed.
