RESOLUTION

**A RESOLUTION AUTHORIZING THE AWARD OF AN EMERGENCY
EQUIPMENT RENTAL CONTRACT TO HERC RENTALS, INC. FOR THE RENTAL
OF A GENERATOR**

WHEREAS, the City of Wildwood (the “City”) experienced a failure and/or interruption in electrical service affecting City Hall and certain municipal operations, thereby creating a condition that jeopardizes the ability of the City to safely provide essential municipal services; and

WHEREAS, on March 6, 2026, the City Engineer provided correspondence to the City regarding the damage and opined that the same resulted in potential harm to the safety and health of the personnel and public utilizing City Hall and needed to be addressed on an emergent basis; and

WHEREAS, the City determined that the immediate rental and installation of a generator was necessary to restore and maintain electrical service and prevent disruption to municipal operations and services; and

WHEREAS, the Local Public Contracts Law permits the award of an emergency contract pursuant to N.J.S.A. 40A:11-6, without public advertising for bids, when an emergency affecting the public health, safety or welfare requires the immediate delivery of goods or the performance of services; and

WHEREAS, the emergent condition and need for the rental equipment was communicated to the City’s Purchasing Agent, Chief Financial Officer, and Business Administrator, who confirmed the emergent nature of the condition and the necessity of awarding the contract immediately; and

WHEREAS, Herc Rentals, Inc., a company specializing in the rental of power generation equipment, provided a proposal and supplied the necessary generator equipment to address the emergent condition and restore electrical service to the affected municipal facility; and

WHEREAS, the proposal submitted by Herc Rentals, Inc., as more particularly set forth in the attached rental quote and supporting documentation, outlines the equipment rental and related services required to address the emergency.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the City of Wildwood, County of Cape May, State of New Jersey as follows:

1. That the provisions of the above preamble of this Resolution are hereby incorporated herein, by this reference, as if set forth at length.
2. That the City hereby ratifies and approves the award of an emergency equipment rental contract to Herc Rentals, Inc., 6951 Norwitch Drive, Philadelphia, PA 19153 for the rental and provision of generator equipment necessary to address the emergency condition affecting City operations, in an amount not to exceed Ten Thousand Nine Hundred Four (\$10,904.00) Dollars as more specifically set forth in the rental proposal and invoice documents attached hereto and incorporated by reference herein.
3. That the Mayor, City Clerk, Chief Financial Officer, and all other appropriate City officials are hereby authorized and directed to take any and all actions necessary to effectuate the purpose of this Resolution, including the processing of payment for the emergency equipment rental.
