RESOLUTION

A RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT TO OPERATE A SURF AND PADDLE BOARD RENTAL AND LESSON CONCESSION ON THE CITY OF WILDWOOD BEACHES

WHEREAS, the City of Wildwood (the “City”) advertised for bids in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. for a contract to operate a surf and paddle board rental and lesson concession on the City beaches pursuant to Resolution No.: 56-1-26; and

WHEREAS, the City received one (1) bid when bids were opened on February 26, 2026, submitted by The Surftopia Vision, LLC (“Surftopia”), and evaluated the same as set forth in the specifications and bid materials; and

WHEREAS, it is recommended that the contract be awarded to Surftopia as the highest responsible bidder submitting the most advantageous bid to the City, with a bid in the amount of Ten Thousand (\$10,000.00) Dollars for the 2026 and 2027 seasons; and

WHEREAS, the City and Surftopia acknowledge that the City’s bid specifications and Surftopia’s bid submission, incorporated by reference herein, shall govern the payment terms and rights and responsibilities of the parties.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the City of Wildwood, County of Cape May, State of New Jersey as follows:

1. That the provisions of the above preamble of this Resolution are hereby incorporated herein, by this reference, as if set forth at length.
2. That a contract to operate a surf and paddle board rental and lesson concession on the City beaches is hereby awarded to The Surftopia Vision, LLC, 809 Beach Creek, North Wildwood, NJ 08260 with payment due to the City in the amount of \$5,000 per season for the 2026 and 2027 seasons, for a total contract value of \$10,000 to be paid in the manner and form as set forth in the specifications and bid documents and subject to all of the terms therein.
3. That notice of this resolution and award shall be published as required by law.
4. That the Mayor and City Clerk are hereby authorized and directed to execute the contract on behalf of the City, and to take all other actions necessary to effectuate the purpose thereof.
