RESOLUTION

**A RESOLUTION AUTHORIZING THE EXECUTION OF AN ADDENDUM TO THE
PROFESSIONAL SERVICES CONTRACT WITH DEBLASIO & ASSOCIATES IN THE
INCREASED AMOUNT OF \$30,000.00**

WHEREAS, the City of Wildwood (the “City”) awarded a professional services contract to DeBlasio & Associates (“DeBlasio”) to serve as the City Engineer as authorized by Resolution No.: 20-1-26, attached hereto and incorporated by reference herein, at the January 7, 2026 municipal meeting; and

WHEREAS, the City originally awarded the professional services contract to DeBlasio in an amount not to exceed Eighty Thousand (\$80,000.00) Dollars to cover general engineering services for the City; and

WHEREAS, the City of Wildwood Water and Sewer Utility have a need for general engineering services and the City wishes to amend DeBlasio’s contract to include an increase in the amount of Thirty Thousand (\$30,000.00) Dollars, with Twenty Thousand (\$20,000.00) Dollars of the increase to be allocated for general engineering services for the Water Utility and Ten Thousand (\$10,000.00) Dollars of the increase to be allocated for general engineering services for the Sewer Utility; and

WHEREAS, the new contract amount with DeBlasio for general engineering services to the City and the Water and Sewer Utility will One Hundred Ten Thousand (\$110,000.00) Dollars; and

WHEREAS, the Local Public Contract Law N.J.S.A. 40A:11-1, et seq. permits for the adoption of a resolution authorizing the award or amendment of a contract for professional services without competitive bids; and

WHEREAS, the Chief Financial Officer for the City of Wildwood has certified as to the availability of funds.

NOW, THEREFORE, BE IT RESOLVED, by the Governing Body of the City of Wildwood, County of Cape May, State of New Jersey as follows:

1. That the provisions of the above preamble of this Resolution are hereby incorporated herein, by this reference, as if set forth at length.
2. That DeBlasio’s general engineering contract is hereby modified and amended to reflect increase in the not to exceed amount by Thirty Thousand (\$30,000.00) Dollars for a new not to exceed amount of One Hundred Ten Thousand (\$110,000.00) Dollars.
3. That all appropriate municipal officials of the City of Wildwood are hereby authorized, empowered, and directed to undertake the necessary actions to further the execution of said Addendum.
4. That notice of this Resolution shall be published according to law.
