RESOLUTION

**AUTHORIZING THE EXECUTION OF CHANGE ORDER NO. 1 WITH ASPHALT
PAVING SYSTEMS IN CONNECTION WITH NEW JERSEY AVENUE SANITARY
SEWER AND WATER MAIN IMPROVEMENTS IN WILDWOOD CREST, D&A
PROJECT #WCU-007**

WHEREAS, the City of Wildwood (the “City”), together with the Borough of Wildwood Crest, contracted with Asphalt Paving Systems for services and materials associated with the New Jersey Avenue Sanitary Sewer and Water Main Improvements project in Wildwood Crest (hereinafter “Project”); and

WHEREAS, the Project Engineer for the Borough, DeBlasio & Associates has recommended Change Order No. 1, annexed hereto and incorporated by reference herein, that increases the City’s financial contribution to the project by \$137,024.40 in order to replace watermain on 100 W. Block of Denver Avenue; and

WHEREAS, the revisions to the contract and Change Order are necessary in order to complete the Project in the most cost-effective manner for the City; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the City of Wildwood, County of Cape May, State of New Jersey as follows:

1. That the provisions of the above preamble of this Resolution are hereby incorporated herein, by this reference, as if set forth at length.
2. That the contract between the City of Wildwood and Asphalt Paving Systems regarding the New Jersey Avenue Sanitary Sewer and Water Main Improvements project in Wildwood Crest is hereby modified and amended to reflect the substantive portions of Change Order No. 1 and to reflect an increase in the amount of One Hundred Thirty-Seven Thousand Twenty-Four Dollars (\$137,024.40) Dollars and Forty Cents.
3. That all appropriate municipal officials of the City of Wildwood are hereby authorized, empowered, and directed to undertake the necessary actions to further the execution of said Change Order No. 1.
4. That notice of this Resolution shall be published according to law
