**RESOLUTION**

**A RESOLUTION AMENDING RESOLUTION NO. 455-12-25 REGARDING A  
CONTRACT WITH NEW JERSEY BUSINESS SYSTEMS FOR THE INSTALLATION  
OF SECURITY CAMERAS**

**WHEREAS**, the City of Wildwood (the “City”) previously authorized the award of a contract with New Jersey Business Systems (“NJBS”) for the installation of Security Cameras for the Fire Department, Police Department and City Hall through a purchasing cooperative; and

**WHEREAS**, the City previously amended the contract by way of Resolution No. 455-12-25 on December 10, 2025 to account for on-site conditions and wishes to further amend the contract to adjust for the final amount of work performed; and

**WHEREAS**, a portion of the work to be performed by NJBS under the amended contract was performed by a separate contractor under a separate contract during the electrical outage in the winter of 2026 pursuant to an emergency contract, and the contract with NJBS needs to be amended accordingly.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Commissioners of the City of Wildwood, County of Cape May, State of New Jersey as follows:

1. That the provisions of the above preamble of this Resolution are hereby incorporated herein, by this reference, as if set forth at length.
2. That Resolution No. 455-12-25 is hereby amended to reflect a reduction in the amount of the contract with New Jersey Business Systems, 7C Marlen Drive, Robbinsville, NJ 08691 by \$696.00 from One Hundred Eighteen Thousand Nine Hundred Thirty-Seven and 67/100 (\$118,937.67) Dollars to One Hundred Eighteen Thousand Two Hundred Forty-One and 67/100 (\$118,241.67) Dollars.
3. That the remaining provisions of Resolution No. 455-12-25, except as amended herein, shall be unmodified by this resolution and shall remain in full force and effect.
4. That the Mayor, City Clerk and any other appropriate City Officials hereby authorized and directed to execute the contract and directed to take all such actions necessary to effectuate the purposes of this resolution.
