RESOLUTION

**A RESOLUTION AMENDING RESOLUTION NO. 151-3-26 REGARDING AN
EMERGENCY REPAIR CONTRACT WITH ANZELONE ELECTRICAL COMPANY, LLC**

WHEREAS, the City of Wildwood (the “City”) experienced a failure in electrical service affecting City Hall that resulted in potential harm to the safety and health of the personnel and public utilizing City Hall and needed to be addressed on an emergent basis; and

WHEREAS, the City awarded an emergency repair contract to Anzelone Electrical Company, LLC (“Anzelone”) pursuant to N.J.S.A. 40A:11-6 by way of Resolution No. 127-3-26, incorporated by reference herein, at the March 11, 2026 Board of Commissioners Meeting; and

WHEREAS, the continued electrical failure and ongoing investigation have revealed conditions requiring additional work that could not have been reasonably anticipated at the time of the initial emergency award, and which continue to pose a threat to public health, safety, and welfare, resulting in an increased scope of work for Anzelone as necessary to address the emergent condition and the City amended the contract by way of Resolution No. 151-3-26; and

WHEREAS, when completing project closeout paperwork and administrative reconciliation, the City identified an invoice from Anzelone in the amount of Eight Hundred Ninety and 80/100 (\$890.80) Dollars that should have been reflected when Resolution No. 151-3-26 was adopted; and

WHEREAS, the City wishes to amend the emergency contract with Anzelone, as modified by Resolution No. 151-3-26, to reflect a final contract amount of One Hundred Eighty-Three Thousand Four Hundred Forty-Five and 80/100 (\$183,445.80) Dollars; and

WHEREAS, the CFO has certified as to the availability of funds.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the City of Wildwood, County of Cape May, State of New Jersey as follows:

1. That the provisions of the above preamble of this Resolution are hereby incorporated herein, by this reference, as if set forth at length.
2. That the emergency contract awarded to Anzelone Electrical Company, LLC, 1102 Route 9 South, Cape May Court House, NJ 08210 and Resolution No. 151-3-26 are hereby amended to increase the not-to-exceed contract amount to One Hundred Eighty-Three Thousand Four Hundred Forty-Five and 80/100 (\$183,445.80), as more specifically set forth in the subject invoices, attached hereto and incorporated by reference herein.
3. That the Mayor, City Clerk, Chief Financial Officer, and all other appropriate City officials are hereby authorized and directed to take any and all actions necessary to effectuate the purpose of this Resolution, including the processing of payment for the emergency work performed.
4. This Resolution shall be effective only upon certification of available funds by the Chief Financial Officer.
