RESOLUTION

**RESOLUTION AUTHORIZING AN AMENDMENT TO A CONTRACT WITH
COLLIERS ENGINEERING & DESIGN FOR OUT-OF-SCOPE SERVICES IN CONNECTION
WITH PHASES 7A AND 8 OF THE BOARDWALK REHABILITATION PROJECT**

WHEREAS, the City of Wildwood contracted with Colliers Engineering & Design (“Colliers”) for engineering and design services associated with Phases 7A and 8 of the Boardwalk Rehabilitation Project; and

WHEREAS, Colliers has submitted a proposal to the City to provide EDA Grant Support Services beyond the original scope of work to be provided in connection with the Project; and

WHEREAS, the additional work will result in a contract increase in the amount of \$7,000.00 for a new contract amount of \$504,400.00; and

WHEREAS, the City has reviewed the proposal and determined that the amendment as contemplated is necessary to complete the project in the most impactful, efficient and cost-effective manner for residents of the City of Wildwood; and

WHEREAS, the Chief Financial Officer for the City of Wildwood has certified as to the availability of funds.

NOW, THEREFORE, BE IT RESOLVED, by the Governing Body of the City of Wildwood, County of Cape May, State of New Jersey as follows:

1. That the provisions of the above preamble of this Resolution are hereby incorporated herein, by this reference, as if set forth at length.
2. That Colliers’ contract for Phases 7A and 8 of the Boardwalk Rehabilitation Project is hereby modified and amended to include the additional scope of work as set forth in the March 27, 2026 proposal, attached hereto and incorporated by reference herein, and to include an increase in the amount Seven Thousand (\$7,000.00) Dollars for a new contract amount of Five Hundred Four Thousand Four Hundred (\$504,400.00) Dollars.
3. That all appropriate municipal officials of the City of Wildwood are hereby authorized, empowered, and directed to undertake the necessary actions to further the execution of the contract amendment.
4. That notice of this Resolution shall be published according to law.
