**RESOLUTION**

**A RESOLUTION AUTHORIZING THE EXECUTION OF A CONTRACT WITH  
NEW JERSEY BUSINESS SYSTEMS FOR VARIOUS PARKS SECURITY**

**WHEREAS**, the City of Wildwood, pursuant to N.J.S.A. 40A:11-12a and N.J.A.C. 5:34-7.29(c), may by resolution and without advertising for bids, purchase any goods or services under the State of New Jersey Cooperative Purchasing Program for any State contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

**WHEREAS**, the City of Wildwood has the need, on a timely basis, to purchase goods or services utilizing State contracts; and

**WHEREAS**, the City of Wildwood has obtained (2) quotes from State Contract Vendor New Jersey Business Systems State Contract#23-TELE-45460 for Fox Park Cameras and Recreation Center and Playground Cameras and;

**WHEREAS**, the City of Wildwood intends to enter into contract with New Jersey Business Systems through this resolution which shall be subject to all the conditions applicable to the current State contracts; and

**WHEREAS**, the City of Wildwood has a need for the purchase and installation of security cameras at Fox Park and Recreation Center and Playground, in the amount of Forty-Five Thousand Five Hundred Eight Dollars and Ninety-One Cents (\$45,508.91); and

**WHEREAS**, the Chief Financial Officer of the City of Wildwood has certified that there are sufficient funds available to purchase said vehicles.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Commissioners of the City of Wildwood, County of Cape May, State of New Jersey that the City of Wildwood authorizes the Qualified Purchasing Agent to contract for the purchase and installation of security cameras for Fox Park and Recreation Center and Playground from the approved New Jersey State Contract Vendor, pursuant to all conditions of the individual State contracts.
