**RESOLUTION**

**A RESOLUTION AUTHORIZING THE AWARD OF CONTRACT FOR THE LEAD SERVICE LINE REPLACEMENT PROGRAM – PHASE 3, CONSTRUCTION CONTRACT 3 TO SOUTH STATE, INC.**

**WHEREAS**, the City of Wildwood (the “City”), in accordance with the New Jersey Local Public Contracts Law (“LCPL”), advertised for bids for construction services associated with the Lead Service Line Replacement Program – Phase 3, Construction Contract 3 (hereinafter the “Contract”) pursuant to Resolution No. 198-4-26, and

**WHEREAS**, the City received one (1) bid in connection with the advertisement of the Contract when bids were opened on June 10, 2026; and

**WHEREAS**, said bid has been reviewed by the City and the State of New Jersey Department of Environmental Protection (“NJDEP”) and the City has recommended, with authorization from the NJDEP, that the Contract be awarded to South State, Inc., 202 Reeves Road, P.O. Box 68 Bridgeton, NJ 08302 as the lowest responsible bidder for Lead Service Line Replacement Program – Phase 3, Construction Contract 3, in an amount not to exceed Nine Million Forty Six Thousand One Hundred Ninety Five (\$9,046,195.00) Dollars; and

**WHEREAS**, the Chief Financial Officer of the City of Wildwood has certified the availability of funds and received approval from the New Jersey Infrastructure Bank; and

**WHEREAS**, the City wishes to award the Contract to South State for Lead Service Line Replacement, Phase 3, Construction Contract 3 as set forth in the Project Specifications and Bid.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Commissioners of the City of Wildwood, County of Cape May, State of New Jersey as follows:

1. That the provisions of the above preamble of this Resolution are hereby incorporated herein, by this reference, as if set forth at length.
2. That a contract for Lead Service Line Replacement Program – Phase 3, Construction Contract 3, is hereby awarded to South State, Inc., 202 Reeves Road, P.O. Box 68 Bridgeton, NJ 08302 to perform the project as set forth in the bid specifications for an amount not to exceed Nine Million Forty-Six Thousand One Hundred Ninety-Five (\$9,046,195.00) Dollars
3. That a Notice of Award shall be published as required by law within ten (10) days of passage of this Resolution, which notice shall state that this Resolution and the contract are on file and available for public inspection in the office of the City Clerk.
4. That the Mayor and City Clerk are hereby authorized and directed to execute the contract on behalf of the City, and to take all other actions necessary to effectuate the purpose thereof.
