WHEREAS, Monday, February 9, 2026, The Tourim Development Committee approved and adopted the Sunday Night Concert Series for the 2026 season; and

WHEREAS, The Chief Financial Officer, Susan Plaza certified funds for the musical entertainment lineup for the 2026 Sunday Night Conert Series, for each Sunday during the Summer Season from June 28, 2026 until Sunday, August 30, 2026; and

WHEREAS, during the June 28, 2026 Commissioners Meeting “The Business” Sunday night concert was passed by Resolution No. 269-6-26 and during the July 5, 2026 Commissioners Meeting the “Blue Magic” concert was passed by Resolution No. 287-6-26; and

WHEREAS, the remaining performances 7/12/26-8/30/26 were held until all adequate paperwork was submitted and all paperwork was finalized on July 16, 2026; and

WHEREAS, these concerts are free events produced by the Tourism Development Committee and the City of Wildwood Special Events Department for the public in Fox Park; and

WHEREAS, the total cost broken down by each band from 7/12/26-8/30/26 below amounts to \$37,400.00 and each band has an individual contract for the specified amount below.
