**RESOLUTION**

**RESOLUTION AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN  
CONTRACT TO MICHAEL P. CHAPMAN FOR UTILITY PROJECT MANAGEMENT**

**WHEREAS**, Michael P. Chapman has submitted a proposal to the City of Wildwood (the “City”) offering Project Management Services in connection with utility projects and has demonstrated extensive experience in said areas; and

**WHEREAS**, the Board of Commissioners has reviewed the same and wishes to enter into an agreement with Michael P. Chapman for part-time Utility Project Management services, as a non-fair and open contract pursuant to “Pay to Play” laws, N.J.S.A. 19:44A-20.4 et seq; and

**WHEREAS**, the total value of the agreement with Michael P. Chapman will exceed \$17,500.00; and

**WHEREAS**, Michael P. Chapman has completed and submitted a Business Entity Disclosure Certification which certifies that said entity has not made any reportable contributions to a political or candidate committee in the City of Wildwood in the previous one year, and that the contract will prohibit it from making any reportable contributions for the term of the contract.

**NOW THEREFORE BE IT RESOLVED** by the Board of Commissioners of the City of Wildwood, County of Cape May, State of New Jersey as follows:

1. That authorization is hereby granted to enter into an agreement with Michael P. Chapman, not to exceed (\$41,000.00) Dollars for Utility Project Management services, and that the appropriate City officials are hereby authorized to sign any and all documents in furtherance of the same.
2. That Michael P. Chapman’s duties, responsibilities, and services shall include, but not be limited to, assure capital projects continue to move forward towards construction and completion and to assist utility staff in an advisory capacity on an as needed basis.
3. That the Business Disclosure Entity Certification and Determination of Value provided by Michael P. Chapman shall be placed on file, together with this Resolution.
4. That the Mayor and City Clerk are hereby authorized and directed to execute the contract on behalf of the City, and to take all other actions necessary to effectuate the purpose thereof.
