**RESOLUTION**

**A RESOLUTION AUTHORIZING A CONTRACT INCREASE WITH DEBLASIO & ASSOCIATES, P.C. FOR ENGINEERING DESIGN AND CONSTRUCTION PHASE SERVICES FOR THE NEW JERSEY AVENUE SANITARY SEWER AND WATER MAIN IMPROVEMENTS PROJECT**

**WHEREAS**, the City of Wildwood (the “City”) awarded a professional services contract to DeBlasio & Associates, P.C. (hereinafter “DeBlasio”) in the amount of Fifty Thousand (\$50,000.00) Dollars for engineering and construction phase services in connection with the New Jersey Avenue Sanitary Sewer and Water Main Improvements Project (the “Project”) by way of Resolution No. 363-9-25 at the September 24, 2025 Board of Commissioners Meeting; and

**WHEREAS**, DeBlasio has submitted a revised proposal to the City, annexed hereto and incorporated by reference herein, to expand the scope of the contract in the amount of Ten Thousand (\$10,000.00) Dollars to include engineering and construction services for Denver Avenue for a new contract total of Sixty Thousand (\$60,000.00) Dollars; and

**WHEREAS**, the City wishes to amend the professional services agreement with DeBlasio as set forth in the proposal; and

**WHEREAS**, the City CFO has certified as to the availability of funds.

**NOW THEREFORE BE IT RESOLVED** by the Board of Commissioners of the City of Wildwood, County of Cape May, State of New Jersey as follows:

1. That the professional services agreement between the City and DeBlasio & Associates, P.C., 4701 New Jersey Avenue, Wildwood, NJ 08260 as authorized by Resolution No. 363-9-25 is hereby amended to reflect the increased scope of work as set forth in the January 29, 2026 proposal, annexed hereto and incorporated by reference herein, and to include a contract increase in the amount of Ten Thousand (\$10,000.00) Dollars for a new contract total of Sixty Thousand (\$60,000.00) Dollars.
2. That the Business Disclosure Entity Certification, Determination of Value Certification, Political Contribution Disclosure Form and Stockholder Disclosure Certification referenced hereinabove be placed on file with this resolution.
3. That the Mayor and City Clerk are hereby authorized and directed to execute the contract amendment on behalf of the City, and to take all other actions necessary to effectuate the purpose thereof.
4. That a copy of this resolution be placed on file with the City Clerk and that notice be published as required by law.
